I, the undersigned, in consideration of my participation in the Petoskey Stone Festival 5k Off-Road Trail Race (the "Race") operated by the Antrim County Petoskey Stone Festival, Antrim County, with the help of other parties set forth herein (Collectively referred to herein as the "Festival"), hereby certify the following:

I understand that participating in a road race involves certain risks, including, but not limited to, falls, contact with other participants, the effects of weather, conditions of the trail/race course, uneven terrain, roots and rocks, loose and/or muddy (wet) soils and grasses, the possible reckless conduct of other participants, and other risks, known and unknown, which may result in property damage, serious personal injury or death. All stresses and hazards associated with this activity cannot be foreseen. I am voluntarily participating in the Race, with full knowledge of dangers involved, and hereby agree to accept any and all inherent risks or property damages, personal injury or death. I am participating in the Race at my own risk and I am aware and understand that I am responsible for my own safety.

I agree to abide by all policies and procedures of the Festival with respect to the Race. The Festival reserves the right to deny or terminate my participation in the Race at any time, for any reason.

I hereby consent to the use by the Festival, and its agents, assigns and licensees, of my name, photo, likeness or film, videotape and/or sound recording of me, to promote the Petoskey Stone Festival.

I understand and acknowledge that the festival has no duty to provide me with medical treatment. I further understand and agree that I am financially responsible for any medical treatment that I may receive before, during, or after the race.

I, for myself, or as guardian/parent, and for my/their heirs, executors, personal representatives, successors and assigns, agree to release, discharge, defend, hold harmless and indemnify the Festival, and its elected officers, officers, directors, employees, committee members, affiliates, agents, servants, successors, assigns, sponsors and representatives, including Antrim County, Antrim Conservation District, Antrim County Road Commission, and Torch Lake Township, of and from any and all claims, actions, causes of action, demands, rights, damages, costs, loss of service, expenses and compensation whatsoever, which may arise, or in the future accrue on account of or in any way growing out of any and all known and unknown, foreseen and unforeseen, bodily and personal injuries, property loss or damage, or the consequences which result from or in any way related to my participation in the Race, including any claims RELATED TO COURSE DESIGN OR CONDITION, WEATHER, THE ACTS OF SPECTATORS, OR OTHER PARTICIPANTS, OR, that are based on the ordinary negligence on the part of the Festival, its agents, volunteers, directors, elected officers, officers, employees or other parties named above.
